Competition rules

Prize draw organised by LISER, to be drawn in the presence of a bailiff

- 1. The public institution known as Luxembourg Institute of Socio-Economic Research, herein referred to as "LISER" or "Centre", located at Maison des Sciences Humaines 11, Porte des Sciences, L-4366 Esch-sur-Alzette/Belval, and represented by its current statutory bodies, is organising a competition in connection with the **2023 Luxembourg child and youth well-being survey** (herein referred to as "Survey").
- 2. The competition begins on June 05th, 2023 and ends on July 15th, 2023.
- 3. The competition is open to children participating in the Survey for whom parents or legal guardians have given their consent. The children concerned by the survey reside in Luxembourg and were 8, 10, 12, 14 or 16 years old on 31 December 2022. Questionnaires completed after the closing date will not be eligible for the competition.
- 4. Staff (both salaried and independent) who work for the Centre organising the competition, and family members of the aforementioned individuals, may not enter this competition. Only persons who consent to participate to the competition will take part of the draw.
- 5. The prizes to be won by age category are as follows:
 - Prize n° 1: 1 Emotion gift card at Europa Park (worth €200)
 - Prize n° 2: 4 entries to Laser Game Howald
 - Prize n° 3: 14+2 gift box (4 cinema vouchers + 2 Food & Drink vouchers)
 - Prize n° 4: 1 gift card Librairie Ernster (worth €50).
- 6. The draw will take place during the week of 24th and 28th July 2023, in the presence of a bailiff. A total of 12 people shall be drawn 4 for the 8 years old, 4 for the 10 and 12 years old and 4 for the 14 and 16 years old and declared to be the winners.
 - Prize-winners shall be informed of their win by email. They will then be able to collect their prizes at LISER's premises at Maison des Sciences Humaines 11, Porte des Sciences L-4366 Esch-sur-Alzette/Belval, Luxembourg.
 - Winners shall have until the 22nd of September 2023 to collect their prizes. Should any winners not have made themselves known by this date, the prizes shall become the property of LISER, as organising entity responsible for the draw, who shall then dispose of the prizes as it sees fit.

on the survey website (https://childweb.liser.lu). The full text of the rules will be made available to participants when they take part of the survey.

- 8. Entry to the competition is free of charge. Entry to the competition is solely as described in the present rules.
- 9. No complaints can be entertained concerning how the competition is organised, except in the case of gross negligence or wilful misconduct on the part of the head of the Centre. Similarly, the names of the prize-winners drawn can in no case be contested, for any reason whatsoever, except in the case of gross negligence or wilful misconduct.
- 10. LISER cannot exchange the prizes for other products or services, nor for their value in cash. The allocation of prizes can in no case be contested, for any reason whatsoever, except in the case of gross negligence or wilful misconduct on the part of the head of the Centre.
- 11. LISER agrees to respect the current regulations concerning data protection.

 LISER collects personal data with the participants' consent, in order to register and manage their draw entries.
 - LISER agrees to use personal data solely for the purposes for which they are collected and to ensure they remain confidential at all times. No personal data shall be passed on to third party organisations.
 - LISER agrees to tell all those concerned how they can exercise these rights as simply as possible.
 - All data collected for this competition shall be destroyed by LISER once the lottery is closed.
- 12. The liability of the Centre and its various bodies, staff and agents in the context of this competition, irrespective of the legal reason, is limited to cases of gross negligence or wilful misconduct.
- 13. The competition organisers reserve the right to change or interrupt the competition should any major event make it impossible to hold it. Should any clauses be or become invalid, the other entry rules still apply.
- 14. The competition and any questions concerning the interpretation of its rules are governed by Luxembourg law and subject to the jurisdiction of the Luxembourg courts.
